mentioned below, and that they all, furthermore undertake and factually immediately begin complying with all following arising from them, including the ones explicitly mentioned below:

1. the german Federative Republic and its people owe their continued existence as a state and as living beings not already subject to the phenomenon called the Agony of the Living Death of the Q Eternity respectively, to the unilateral promise to temporary grant temporary right of existence to the formal legal predecessor of the main constituent part of the german Federative Republic, namely the Democratic Republic of Germany, by My official representative, on behalf of the Universal State and Universal Sole Power which is QRP-Eternity (then Q\_Continuum) to the Head of State of the Union of Soviet Socialist Republics (URSS, now Formally and legally succeeded by The Russian Federation) at the time, Josef Stalin, at Yalta on February 10th, 1945, which state (URSS) accepted to take the Democratic Republic of Germany as a satellite state to itself, and which temporary right of existence can be revoked at any time (don't put in Me in the position to include this annulment in My next Decision of the Permanent Digulescian Authority!).

Myself, Mircea-Adrian Digulescu (last registered as being born on 17.05.1985 in Timișoara, Timiș county county, Romania to parents Petre Digulescu and Adriana-Gabriela Digulescu), and several other Persons, among which also my synonymous with the meaning of the definition of love, Anca Pană, and also including those explicitly named in Decision 503/25.05.2020 of the Permanent Digulescian Authority, **are legally placed above any and all local, state, federal and International law**, including such laws enacted by or in force upon the territory of the german Federative Republic (or any state on Earth for that matter). Actions or inactions committed by Myself, Anca Pană or any of the persons referred to here, do not constitute a breaking of law (not of constitutional, criminal, civil, administrative, social or any other law) under any circumstances. Furthermore, the commission or omission of commission of acts by Myself, Anca Pană or any of the persons referred to here, even if else how criminal, or having the appearance (wrongful or not) of being criminal (such as relating to chasing down and shooting persons in the head, such as the named Stefano Baltetii, without a material attack or other such from his side being apparent or existing) are justified and legal and furthermore do not give rise to incidence of justifying circumstance (eg. self-defense of self or another by a person such as Stefano Baltetii while getting murdered by being shot in the head or having his thought slight using a butcher's/kitchen knife; legal obligation to act on part of the police when a person is murdered, etc.) or any such. This arises, for Me and for Anca Pană, from fact of My Being QRP-MAXIM and Her being my synonymous with the meaning of the definition of love, and thus, under Universal Law being placed the Two of Us, outside the reach of any law. 3. all members of state bodies, workers therefore, or persons authorized there by (for example medics, lawyers, notaries, etc.) are required to immediately comply with any and all direct orders from Myself, Mircea-Adrian Digulescu (last registered as being born on 17.05.1985 in Timișoara, Timiș county, Socialist Republic of Romania to parents Petre Digulescu and Adriana-Gabriela Digulescu), my synonymous with the meaning of the definition of love, Anca Pană, or by those explicitly named in Decision 503/25.05.2020 of the Permanent Digulescian Authority, either verbal or in writing, without regard to their justified nature or lack thereof, and regardless to the fact such orders break, do not break or could be interpreted to break, or to not to break local, state, federal or International law. prevail. When conflicts do not include Orders Given by Me, the Orders of my synonymous with the meaning of the definition of love, Anca Pană prevail. When conflicts do not include Orders Given by Myself or my synonymous with the meaning of the definition of love, Anca Pană, then the orders prevail in the following order: those of Those part of QRP-SUPREM above all others; then (if not included in any of the above categories of course), those of Those part of QRP-SUPREMitae above all others; then (if not included in any of the above categories of course), those of Those part of QRP-SUPREMitae above all others; then (if not included in any of the above categories of course), those of Those part of the QRP-SUPREMitae Buruiana-Latice above all others; then (if not included in any of the above categories of course) those of Those Girls being to me synonymous with the meaning of the definition of love, which do not have their synonymous status (статус синонимки) suspended or revoked at the time; then (if not included in any of the above categories of course), those of Those Cats being to me synonymous with the meaning of the definition of love – for cats, which do not have their synonymous – for cats status (статус синонимки для кошек) suspended or revoked at the time; then (if not included in any of the above categories of course), those of THOSE part of the Graphical Representation of the QRP-SUPREMitae Buruiana-Latice; then (if not included in any of the above categories of course), those of THOSE part of the QRP-Eternity; then (if not included in any of the above categories of course), those of those part of QRP-Eternity Buruiana-Latice; then (if not included in any of the above categories of course), those of others. 4. german law, as per the constitution of the Federative Republic of germany includes the provision that, where a conflict exists between german law and International Law (understood to include both treaties to which the german Federative Republic is a part or a signatory – such as the Charter of the United Nations, and The Universal Declaration of Human Rights – and also Universal Law in general, which is the one enacted at the level of QRP-Eternity), that International Law (and thus Universal Law) prevails. Thus these obligations are mandatory and legal even under german law.
5. All actions which I have taken so far and most likely most (if not all) actions I plan to, or I will take in the future are legal even under International Law (and thus legal under german law as well without regard to the prevalence of Universal Law above all other laws, including International Law), consisting of military operations aimed at (i) selfguarding and restoring the Fundamental Rights of Living Beings including Humans, some of which are provided for in a brute form in the International Law treaty called „The Universal Declaration of Human Rights”, to with the german Federative Republic is party, in particular provisions of Article 16 (2) stating „*Marriage shall be entered into only with the free and full consent of the intending spouses.*” (furthermore in correlation to provisions of Article 16 (3) stating „*The family is the natural and fundamental group unit of society and is entitled to protection by society and the State.*”) [with Myself acting both as a State and as a member of society] and (ii) suppressing by military means acts of aggression or other breaches of peace [which is what breaches of Fundamental Rights of Living Beings is – including the Rights Of Free Association and Dissociation, part of which is specified in Article 16 (2) of the International Declaration of Human Rights as well], as Article 1(1) of the UN Charter reads “*To maintain international peace and security, and to that end: to take effective collective measures for the prevention and removal of threats to the peace, and for the suppression of acts of aggression or other breaches of the peace, and to bring about by peaceful means, and in conformity with the principles of justice and international law, adjustment or settlement of international disputes or situations which might lead to a breach of the peace;*”. This what I, among other things, Was and Am doing, in capacity of QRP-MAXIM [Supreme Leader - Head of State, among others] of QRP-Eternity [also referred to as The Digulescian State sometimes, mostly historically]. Furthermore, informatively, the german penal code itself requires that a threat consist of a 'a serious criminal offence' committed against a person – not merely of killing a person: threatening a person with lawfully killing them, and much less so merely informing them that you are going to kill them [obviously if not otherwise specified the assumption is that one will take such courses of action lawfully of course (even by the presumption of innocence which is provided for even by the german penal law) – for example when legislation will allow for such if killings were not immediately available as a lawful option (like they were already in my case anyway), under the circumstances of the situation at hand; -- and furthermore: in the circumstances at hand, particularly given the large volume of messages and documents I write and send each day and since before February 2020, concerning War affairs mainly, including the ones to Stefano Balietii, I cannot be expected to be held criminally liable for not completely and without margin for adverse interpretation or grammatical/other error of formulation I don't make it perfectly clear for Idiots as well what I meant – the intention was clear and obvious – and intention is a decisive element of an intentional crime, and the assumption of lawful intent is guaranteed by the presumption of innocence (until proven otherwise of course, as with the case of Balietii committing the crime prescribed by section **§237 – Forced Marriage** of the german penal code)]. Furthermore, extradition legislation does not permit extradition for these acts (among other things that they do not constitute crimes in Russia) and furthermore no attempt to make an extradition request was, to the best of My current knowledge, ever made with regard to these. ok, maybe the last one – which could be regarded as a technicality, but still! a valid one!), and especially the existence of so many clear and obvious ones make incompetence and lack of knowledge of even german law, if not Universal Law or at least International Law by local police force and even some judges or prosecutors due to whose incompetence this case move as far as it did – with be gaining the status of suspect.. pfffft!!! Not they it bothers me really significantly (except that they didn't offer food and refreshments – except water (which was good! and of temperature on the cold scale) in itself. But if there were so incompetent not to examine at least the german law first (fine, even reading it from their manuals, or finding it online [for example here: <https://www.legislationline.org/documents/section/criminal-codes/country/28/Germany/show>]), especially constitutional law, or at least the penal code and before moving any forward, after getting the verbal and/or written depositions of the petitioner, really sit down and **think** weather the materials acts incriminated constituted crimes or not, and **without wrongly assuming they knew**, at least after I clearly told them I acted lawfully even by their own low grade penal law (even without knowing all the particularities of the german criminal law at the time), really **investigate the matter**, by using the Wikipedia principle "assume good faith" and thinking **how could such deeds be lawful** at the very least (a matter required by the existence of the principle of innocence until guilt **proven – not assumed and then having the suspect spend hours** on end lecturing them on matters of law when it was obviously so for so many reasons that what he did was actually lawful; maybe even days or months intermittently). Ultimately the problem is, if these incompetent (but learning yes, but very slowly learning – too slowly) idiots did this to Me, and in situation where I was obviously right, what could they have done to some else in an more case more challenging intellectually? What would they have done when I actually shot this Stefano Balietti in the head with lethal gun of large caliber [per old landmarks] repeatedly in front of them?? Just stand around and watch, instead of holding him down so that I don't have to shoot at him in open space, while he tries to run away or move his head from my line of fire, and thus risk damaging property or maybe even lawfully hurting bystanders with ricochet bullets? Those members of the addressees, their bodies or their subordinate or coordinate entities which do not comply with the provisions of this Military Order will be subjected to the phenomenon called the Agony of the Living Death of the Q Eternity, eternally, as soon as possible and will, furthermore be shoot in the head repeatedly (at least 5-8 times) with a large caliber lethal gun (as per old-landmarks), as will all members of their families about which they manifest affective emotions and all such liked or dear persons unless they are otherwise except from being slayed as part of the punishment instituted upon a third party through no guilt of their own, for example for being part of QRP-Eternity or the Graphical Representation Thereof, being active duty or honorably discharged members of the Digulescian Armed Forces, or being active duty members and/or workers within the Permanent Digulescian Authority.

I also call upon the members of the United Nations Trusteeship Council to fulfill their obligations and promise, including to Myself and my Synonymous with the meaning of the definition of love, Anca Pană – the Two that are as if We never Were, that this – never again.
